- A. Scheduling
 - 1. 2025 Divisions: New divisions were proposed.
 - 2. Championship Meet: St. Michael/St. Mary of Gostyn/St. Joseph volunteered to co-host the Championship meet. Revised schedule to be sent when locations are finalized.
 - 3. Scheduling Committee will continue to secure starters. Once the starter is confirmed and scheduled, Scheduling Chair will email the meet hosts and the starter to transition the relationship
 - 4. League will no longer hire IHSA Field Event Officials at the Championship Meet.

B. Rules

- 1. Meet format: Reminder that the only meets governed by the Rules and By-laws are the Divisional and Championship meets. Other formats (combined JV/Varsity, relay meets) are at the discretion of the meet hosts. Format decisions should be communicated as early as possible. The combined JV/Varsity meet was tested last year. The meet format is more conducive to a smaller number of schools.
